This session will examine the extent of Yemen's current economic challenges, addressing the country's transition to a post-oil economy, the devaluation of the riyal, and the impact of rising prices on households and livelihoods. Panellists will debate the current status of remedial measures to tackle the macro-economic crisis, including the option of direct budget support, and discuss the country's future economic prospects. The panel will also address progress on broader governance reforms and anti-corruption measures.

This session will look at political tensions surrounding the forthcoming parliamentary elections, scheduled for April 2011, and highlight emerging dynamics within the wider political landscape, including the evolution of the opposition coalition and the grievances of the 'non-parties' – the southern separatists and the Houthi insurgents. The panel will address efforts to establish a national dialogue, discuss the implications of the next parliamentary elections and tackle the issue of legitimacy and political inclusion. The panel will also examine the relationship between parliamentary parties and personality politics.
